Preston Community Network (PCN) is an association of voluntary and community sector organisations from the Preston area. The aim of the Network is to give the voluntary and community sector a voice and representation with strategic organisations and to create opportunities for member organisations to work collaboratively to improve people's lives. In particular, PCN will;

- advocate for the voluntary and community sectors with statutory and public services operating in the Preston area
- provide a platform for consortium bids and for attracting further investment into the voluntary and community sector
- provide training and support to the voluntary and community sector to develop its capacity.

Member organisations will be able to nominate somebody from their organisation as a candidate for election at the AGMs as a Trustee/Director of PCN.

Each member organisation will have one vote at the AGM.

### **General Data Protection Regulation**
